Safe digging is no accident! "Call before you dig" is the nonprofit in the Commonwealth of Pennsylvania. If you plan to disturb the earth with powered equipment, you are required by Pennsylvania law to notify the underground utility companies of your intent to do so. Dial 8-1-1. It is important you know what is below!

JESSUP BOROUGH GRANTS RECEIVED 2020

Jessup Borough received \$225,205 to separate the sanitary sewer and stormwater lines along Bridge St. in the borough.

Jessup Borough received \$319,584 to separate the sanitary and storm water outflows by installing new storm water lines for individual storm and sewer system on Front St. and Ward st

Jessup Borough was awarded \$35,000 with possibility of additional funds based on expenses and fund balance. This will cover sanitation stations purchased for Jessup Parks among other things.

If you are a new resident of Jessup Borough, please make sure that your employer has given you a Residency Certification Form to insure that the local tax withheld is remitted to correct municipality.

Total EIT percent is 1 % (.5 % is Municipal portion and .5 % is School District Portion)

Borough and School District Tax Payments: Please issue separate checks for Borough and Valley View School District realestate tax payments. Do not combine on one check.

Vacancies: Property owners that have vacancies in 2021 must wait until December 2021 to submit a request with proof for refund. **You can not deduct them when you pay your bill**.

JESSUP BOROUGH MISCELLANEOUS INFORMATION

WATER AND SEWER INSURANCE: ...highly recommended for homeowners

"The Water company sends your water bill each month and there is an option to purchase water and sewer insurance. Everyone should think about getting this coverage. Last year I had a water break between my house and the road. This year I had a sewer back up. They had to dig up my yard and the road both times. Cost to me without the insurance would have been around \$10,000-15,000. I paid nothing. Also, on your homeowners policy you should have the endorsement for sewer back up to cover cost to the damage inside of your home. The endorsement does not automatically come with your policy. You have to ask your agent for it. Good luck". Pete Larioni

SEWER BACKUPS AND SEWER LINE DAMAGE

Drain pipe or lateral clogging is caused by a mixture of calcium and fat as well. Human urine and corrosion from the pipe(s) produces calcium. When mixed with fats from any source, dense and fairly hard soap takes place. This means that any pipe located in any room inside the property can get clogged by soap formulated by the mixture of calcium and fats on a daily basis.

Grease, oil and fat are common products of foods and or cooking processes. Other daily use products that you may not be aware contain grease; such as fat based soaps and detergents. When cooking or manually washing dishes, do not flush fats, oils, butter, egg shells, and any other greasy substance into the sink. Some common items that do cause damage and unwanted sewer backups, put into the trash instead. Although it may advertise 'flushable', it's not. A complete list can be found on the Borough's website.

DO NOT FLUSH wipes of any kind including baby and facial cleansing or feminine hygiene products.

SNOW REMOVAL ORDINANCE

On the first day when a snowfall event is forecast of three (3) inches or more, no motor vehicle as defined under the Motor Vehicle Code of the Commonwealth of PA shall be parked on the even-numbered side of the street between the hours of 7:00 A.M. and 5:00 P.M. or other hours as deemed appropriate by the Mayor or the Borough Manager. This area will be designated as a "No Parking Zone" for the purpose of cleaning snow.

The following day, parking shall be prohibited on the odd-numbered side of the street which will be designated as a "No Parking Zone" for the purpose of cleaning snow.

Vehicles not removed on designated days for snow removal as stated in Ordinance 3-2021 will

be ticketed and/or towed at owner's expense.

Notice of snow event parking restrictions is deemed accomplished when posted on the Jessup Borough Facebook Page and/or communicated by local print, radio, or television media.

Any person who shall violate any provision of this article shall be fined as follows:

- a. First offense of the winter snow season \$25.00
- b. Second offense of the winter snow season \$50.00
- c. Third or more offense of the winter snow season \$100.00.

No person shall throw, shovel, cast or otherwise move, place, pile, deposit or dump snow or ice removed from sidewalks, driveways, or other areas into the street, public highway, cartway or passageway. Any owner, agent, or tenant of premises in violation shall, upon conviction, be fined twenty-five dollars (\$25.00) and be responsible for the costs of prosecution.

The Borough or its agents shall not be responsible for snow which, through the process of plowing, has been pushed into the entrance of driveways and sidewalks. Each owner, occupant, or tenant of every property fronting upon any street shall be responsible for removing such accumulated snow from the entranceway to such property, subject, however, to Section Four of Ordinance 3-2021.
