A RESOLUTION OF THE BOROUGH OF JESSUP, COUNTY OF LACKAWANNA, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING A FEE SCHEDULE FOR PAVE CUTS AND RELATED FEES REGARDING PAVE CUTS

WHEREAS, The Borough of Jessup, Lackawanna County, Pennsylvania is a duly authorized political subdivision; and

WHEREAS, the Borough of Jessup adopted a "Pave Cut ordinance" by Ordinance No. ____ of 2021; and

WHEREAS, pursuant to said ordinance any fees imposed by said ordinance shall be established by resolution: and

WHEREAS, the Borough has elected to adopt an appropriate Resolution.

NOW THEREFORE, BE IT RESOLVED and IT IS HEREBY RESOLVED by the Council of the Borough of Jessup as follows:

Section 1. That the attached Fee Schedule is hereby adopted for costs incurred for the Borough or its agents, or contractors in carrying out its responsibilities under the Borough's Pave Cut ordinance.

Section 2. In addition to the fee schedule the following additional fees shall be applicable to the work described therein.

2.1 All invoices to permittee or applicant shall be fee plus 10%.

2,2 Inspection fee's between the hours of 5:00 pm and 7:00 am will carry a surcharge of 20%

2.3 Inspection fee's beyond 8 hours in a day will incur a premium surcharge of fee times 1.5. No additional surcharge will be charged.

Section 3. This Resolution shall become effective immediately.

FEE SCHEDULE

Fees shall be as follows:

PERMITS/SERVICES/PENALTY

Fee Processing and issuing a permit \$85.00 ea.

Inspection First hour (minimum inspection) \$55.00/hr ^{1,2,3}

Second hour or hours thereafter or part thereof, per hr. \$55 .00/hr ^{1,2,3}

Penalty for failure to obtain a permit \$600.00/event/day

Penalty for noncompliance with any other Section or part thereof (each day)
\$600.00/event/day

¹-All invoices to permittee shall be fee plus 10%.

²-Inspection fees between the hours of 5:00 pm and 7:00 am will carry a surcharge of 20%

³-Inspection fee's beyond 8 hours in a day will incur a premium surcharge of fee times 1.5. No additional surcharge will be charged.
