From the Desk of Tax Collector Genevieve Lupini

The Jessup Borough Tax Office will no longer be accepting cash payments. Checks or money orders will only be accepted.

<u>Borough and School District Tax Payments</u>: Please issue separate checks for Borough and Valley View School District real-estate tax payments. Do not combine on one check.

<u>Vacancies:</u> Property owners that have vacancies in 2023 must wait until December 2023 to submit a request with proof for refund. You cannot deduct them when you pay your bill.

Jessup Borough Local Wage Tax

If you are a new resident in the Borough please make sure to update your local tax forms with your employer. The 1% withholding should be remitted to Jessup Borough (PSD Code 351003). Wage taxes are collected by Berkheimer Tax Innovations, the collector appointed by Lackawanna County.



Fertilizers—nitrogen and phosphorus—are good for plants but not for water quality. In ponds, streams and rivers, fertilizers are pollutants that harm fish and wildlife, can cause smelly algae blooms, and can even affect drinking water.

Be a Lawn Hero: Protect Your Local Waterways!

- Recycle grass clippings with a mulching mower. Clippings are a free, natural fertilizer—and all that most lawns need.
 - Sweep or blow grass clippings and fertilizers off of pavement, and away from storm drains and wetlands.

Learn More About Soil Testing

Of those who fertilize, a mere 10-20% get a soil test to understand their exact lawn needs. (CWP 1999).


Save hundreds on wasted fertilizer with an inexpensive soil test from the UMass Soil Test Lab. It gives you scientific fertilizer recommendations for your unique lawn.

- Never fertilize before a heavy rainstorm (light rain is ok).
 - Don't apply fertilizer with phosphorous to an existing lawn. It's illegal in MA unless a soil test says you need it.
 - Choose fertilizers with 75-100% "slow-release" or "water insoluble" nitrogen.

Lawn fertilizers (and other pollutants such as pesticides, oil, gasoline, antifreeze and dog waste) mix with rain and irrigation runoff, wash into storm drains on the street, and empty into local waterways, with no filtration or treatment.







It's Your Responsibility as a Dog Owner

When you walk your dog, make sure to carry a plastic bag with you so that you can pick up the waste and dispose of it in a trash can (and never in a storm drain).

Dog waste carries high levels of harmful E. coli bacteria and other pathogens. When dog waste is left on the ground, the bacteria and pathogens can wash into storm drains and enter local waterways, which impacts recreational opportunities, like swimming, fishing, and boating.

It's a Really Big Deal

Dogs produce a lot of waste, which over time, can pose a health threat to swimmers, wildlife, and water quality.


The Environmental Protection
Agency estimates that two or three
days' worth of droppings from a population of about 100 dogs would contribute
enough bacteria to temporarily close a bay
and all watershed areas within 20 miles of
it to swimming and shell fishing.

Fecal waste-contaminated water can cause people to have serious health problems.

Deliberately leaving pet waste on the ground is not only unpleasant and unhealthy, it's often punishable by fines.

It reduces the spread
of disease and helps
protect our local
water resources.

A very successful Thanks for Giving food drive was held to support the Bread Basket Mid-Valley Food Distribution Center located here in Jessup. Grant funds awarded and more funds sought after:

So far this year, Jessup has been awarded \$561,000.00 for improvements at the youth sports complex. Additionally, the Borough has been awarded \$120,170.00 for the planning and design of a stormwater system.

Many grant applications have been submitted to address the deteriorating infrastructure, and absence of infrastructure in some neighborhoods. Additional applications have been submitted for improvements at some of Jessup's recreational spaces, as well.

Jessup Borough Council encourages all residents to sign up for **The Jessup 411**.

Jessup Borough, along with emergency services are excited to announce that **The Jessup 411** is now available to all residents and visitors to our community! **The Jessup 411** is a FREE SERVICE that allows individuals to sign up for notifications sent from the Borough. This could be changes to our refuse/recycling schedule, holiday schedules, events happening in our Borough, and many more unforeseen issues that may occur during the year.

The Jessup 411 enables officials to notify the community in real time. The Jessup 411 enables residents and visitors to the community to sign up for free to receive timely and actionable alerts via text, voice message, or email. Residents can also identify when and how they are alerted. A cell phone is not required to use this service. You can register today by visiting

Jessup Borough residents and visitors to the community can also download the Smart911 app to sign up for the **The Jessup 411** to receive key information needed in an emergency. The Smart911 app provides enhanced functionality by sending targeted alerts based on the user's location. Smart911 app users will receive the highest priority National Weather Service alerts based on their real time location. Download the Smart 911 app on the Apple Store or Google Play Store.

Jessup Borough Refuse & Recycling Calendar 2023

The Borough of Jessup contracts refuse and recycling collection to a private hauler, J.P. Mascaro. If you have any problems you may contact them directly at (800) 243-7575. Regular pickup day is Tuesday. Their holidays are New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. If any of these days falls on a Monday, collection will be on Wednesday as indicated in YELLOW on the calendar.

Single-Stream Recycling allows all recyclables to be placed in one container. There is no need to separate items such as cans, bottles, and plastics from newspapers, cardboard, etc.

Metal: Tin and aluminum cans, empty paint cans.

Glass: Jars and bottles

 ${\bf Cardboard: Empty \ and \ flattened \ and \ loose.} \ {\it Please \ note \ pizza \ boxes \ are \ not \ recyclable \ materials.}$

Mixed Paper: Newspaper, magazines, mail (junk and personal), phone books, food boxes (remove plastic liner), computer paper, flyers, wrapping paper (no foil or plastic wrap), soda and beer cartons (no food-soiled paper, please!)

Plastic Containers: Not all plastics are acceptable recyclable material (mostly beverage and detergent containers). More information can be found on the Borough's website.

Electronics: Televisions, computers, printers, computer monitors, or any other electronic device are not eligible for curbside collection. These items <u>will not</u> be picked up by J.P. Mascaro or the Borough. The **Covered Device Recycling Act** requires these items be recycled. Please contact Lackawanna County Recycling Center for further information Monday through Friday from 7:00 AM-3:15 PM at (570) 963-6868 or visit their website recycling.lackawannacounty.org.

Any trash placed in recycling containers will not be picked up and will be left at the curb. Lost or broken recycling receptacles can be replaced by contacting the Borough office during normal business hours.

Two (2) bulk items are permitted per household per week for regular trash collection. Some examples include sofas, dressers, tables, and chairs. Please visit the Borough website for a complete list of acceptable bulk items. Please note that mattresses and box springs <u>MUST</u> be completely wrapped and sealed in plastic or they will be left at the curb.

Borough Recycling Programs

Recycling Bins: If any residents would like to obtain a new and/or additional recycling bin, please contact the Borough Office during regular business hours.

E-Waste Recycling: Please keep a look out for announcements for our 2023 event.
