Controller Benjamin Cardoni gave an overview of the Borough financials for the month.

Borough Manager Coleen Watt announced there will be a TASA presentation December 10, 2025, where Jessup Borough will be looking for phase 2 of the Hill Street Sidewalk Project. She met with the new Building Inspector/Zoning Officer to review the processes for building and zoning moving forward.

Gregg Betti announced the Hometown Hero banners will be returned on Saturday, December 13, 2025. There is currently a calendar fundraiser going on for Jessup's 150<sup>th</sup> Birthday. Calendars are \$10.00 and money will go towards the parade, social and July 5<sup>th</sup> celebrations.
